Paprika oleoresin (also known as paprika extract or oleoresin paprika) is an oil-soluble extract derived from the fruits of *Capsicum annuum* or *Capsicum frutescens* that is largely used as a food colourant and/or flavouring. It's made up of vegetable oil (usually between 97 and 98 percent), capsaicin (the main flavouring element that gives it pungency in higher quantities), and capsanthin and capsorubin (the main colouring compounds) (among other carotenoids).

It's a lot milder than capsicum oleoresin, and it usually doesn't have any capsaicin at all. Percolation with a number of solvents, primarily hexane, is used to extract the material, which is then removed before usage. After that, vegetable oil is applied to ensure a consistent colour saturation. Many popular foods include the oleoresin paprika, which is sometimes referred to as paprika oleoresin on labels.
